(the Company ) held a special meeting of its stockholders (the Special Meeting ) in connection with the Company s previously announced pending merger (the Transaction ) with Cape Bancorp, Inc. ( Cape ) pursuant to the terms of the Agreement and Plan of Merger, dated as of January 5, 2015, by and among the Company, Cape and Justice Merger Sub Corp. ( Merger Sub ).

Proposal No. 1 Approval of the issuance of the shares of Company common stock in connection with the merger of Merger Sub, a wholly-owned subsidiary of the Company, with and into Cape.
