Hi everyone,

I m excited to share with you today a key milestone in the GetGo and LogMeIn integration planning. This morning we announced the senior leadership team that will lead the new combined company following the close of our proposed merger. You ll be hearing more in the coming days and weeks, but I wanted to take a minute to share the news and offer some context.

When LogMeIn and Citrix publicly announced the deal in July, we discussed the fact that Ed Herdiech and I would be the CFO and CEO, respectively, and that leaders from both GetGo and LogMeIn would be chosen to be part of a new management team – a team specifically designed to lead a billion-dollar industry leader and one of the world’s preeminent SaaS companies. Since then, I’ve shared a bit more about the highly complementary operating models, products, teams and cultures of our great companies. We each bring strengths to the table, and we each bring unique experience. And as I set about to select this team, I saw an opportunity to bring together proven leaders that would exemplify the best from both – approach we’re taking in all aspects of our integration planning efforts.

So it is my privilege to announce that six members of the current GetGo executive team will be joining the new merged company upon the close of the transaction: Chris Battles (as Chief Product Officer), James Lok (as SVP, Engineering), Scott Romesser (as SVP, Customer Care), Bernd Christiansen (as Chief Innovation Officer), Jennifer Lovette (as Senior Director, Integration Management) and Maria Nguyen (as VP, Strategy).

From the LogMeIn side, the team will include Larry D Angelo (SVP, Sales), Michael Donahue (General Counsel), TJ Ewing (Chief People Officer), Sean Ford (Chief Marketing Officer), Tara Haas (Chief of Staff), Chris Manton-Jones (SVP, International), Rob Lawrence (SVP, Strategy & Corporate Development) and Sandor Palfy (Chief Technology Officer). As we move closer to the date of the merger, employees of both GetGo and LogMeIn will have a chance to meet our new leadership team. Of course, it is important to remember that until close, LogMeIn and GetGo remain separate companies. Our respective senior management teams remain in place and both are focused on leading their individual functions and companies to a strong and successful finish to 2016.

In the meantime, I can't wait to start the next chapter in our companies' histories and I'm thrilled to have the experience of this team ready to lead the way.
