Express Scripts Holding Company posted a video to its intranet site available to its employees on May 2, 2018, a transcript of which is set forth below.

Hi everyone.

We announced strong financial results for our first quarter of 2018, and I wanted to take a few moments to celebrate our success.

First, we are well on track to meet our new solution sales goals. Our solutions deliver on two important commitments: better care for patients and lower cost for payers. The value of our work is resonating with clients and their uptake of our solutions is another example of how we're winning.

Take time for the simple acts of saying thank you, demonstrating care and concern, and being available to your colleagues. Starting in May, and throughout the year, we will provide tools to help you lead your teams during a time of change. The focus of our work remains the same - to put medicine within reach of people who need it.

Many of you have reached out to me with questions about Cigna, and I want to give you a quick update.

While we are still in the early stages, we are excited about the potential. In fact, last week, we had our first team meeting here in St. Louis. Just as we do, Cigna feels strongly about supporting our community, so the team spent part of its first day together by helping The Little Bit Foundation, which helps school children get the things they need. The team at Cigna shares our values and our passion to make healthcare simpler.

I know you want more specifics how will the deal affect me? We have questions and answers available on the Hub and will update those. Going forward, we will let you know as decisions are made and milestones are reached. We are working to close the deal by the end of the year and we remain on track to do that.

Until then, the one thing that doesn't change is our focus on 2018. We have commitments to clients, patients and shareholders to deliver. We will do so.
