This statement is filed on behalf of Peter R. Kellogg and IAT Reinsurance Company Ltd. ("IAT"), a Bermuda corporation. Mr. Kellogg is the sole owner of IAT's voting stock, is a member of IAT's board of directors, and is the President and CEO of IAT. A joint filing agreement of Mr. Kellogg and IAT is attached hereto as Exhibit A.

This statement relates to 4,707,331 shares of Presstek held by IAT and its wholly-owned subsidiaries, 51,200 shares of Presstek held by a foundation controlled by Mr. Kellogg and his wife, plus an additional 74,500 shares held by companies controlled by Mr. Kellogg. Mr. Kellogg has sole dispositive and voting power with respect to the shares of Presstek owned by IAT and its subsidiaries. Mr. Kellogg disclaims beneficial ownership of the shares owned by the foundation and by IAT and its subsidiaries, and this statement should not be deemed to be an admission that Mr. Kellogg is a member of any
