(1) This represents the grant of a performance-based restricted stock award that has restrictions that lapse at varying rates based on certain performance-based criteria. The award has an "overdrive" feature that provides that if the Compound Annual Growth Rate ("CAGR") of the Company's core EPS for FY06 through FY08 is in excess of a certain specified percentage the reporting person is entitled to additional shares. The number of shares listed in Column 4 of Table 1 represents the maximum of shares that may be issued pursuant to the award if the CAGR maximum target is met.

(2) \$0.00 has been inserted to satisfy the requirements to submit this form via the EDGAR system.

(3) Column 5 of Table I includes 596 shares and 602 shares of common stock acquired by the Reporting Person on June 30, 2005 and December 31, 2004, respectively, under the 2002 Employee Stock Purchase Plan of Jabil Circuit, Inc. The reporting person's previously filed Form 4 dated April 29, 2005 reflected in Column 5 of Table I the 602 shares acquired on December 31, 2004 but did not include a footnote identifying the total share holdings of the Reporting Person as including such shares.

(4) Stock Appreciation Rights shall vest at the rate of one-twelfth of the initial shares subject to the award one year and three months after the date of grant (which date of grant was 10/11/2005), with an additional one-twelfth of the initial shares subject to the award vesting on the same calendar date of each successive three month period thereafter, with, as a result, all of the initial shares subject to the award vesting by four years from the date of grant; provided that in all instances the reporting person is an employee of, or consultant (as defined in the relevant stock incentive plan) to, the Company or a subsidiary.
