- (1) As of September 12, 2005, I have 22,079.7133 equivalent shares of stock in Questar's Employee Investment Plan. The number of equivalent shares will fluctuate as Questar's stock price changes; this fluctuation does not reflect any transactions that should be reported.

- (3) I also receive phantom stock units as a result of my participation in an excess benefit plan. I have 1,003.2498 shares in it in addition to my shares in a deferred compensation plan. I also receive dividends.
