Item 1.

Security and Issuer

This Amendment No. 1 amends the Schedule 13D filed with the Securities and Exchange Commission on December 31, 2009 (the "Original 13D") by on behalf of Christopher Bunka, C.A.B. Financial Services Ltd., and 0743608 B.C. Ltd, (together the "Reporting Persons") relating to the shares of common stock, par value \$0.001 ("Common Stock") of Eerntopia Corporation, a corporation formed under the laws of the State of Nevada (the "Issuer"). The principal executive office of the Issuer is Suite 1004, 1708 Dolphin Avenue, Kelowna BC Canada V6E 4A4. Unless otherwise stated the Original 13D remains in full force and effect. Terms used therein and not defined herein have the meaning ascribed thereto in the Original 13D.

Item 4.

#### Purpose of Transaction

The Reporting Persons acquired the Shares for investment purposes. Any such acquisitions or dispositions may be made, subject to applicable law, in open market transactions, privately negotiated transactions or, in the case of dispositions, pursuant to a registration statement. The Reporting Persons may act independently in evaluating and effecting any such transactions.
