- (1) 965 previously owned shares having a market value of \$25.33 per share were delivered in payment of the option price of \$12.54 per share for 1,950 shares acquired pursuant to the exercise of an option granted under the 2002 Plan.
 - (2) 1,950 shares were acquired pursuant to the exercise of an Incentive Stock Option granted under the 2002 Plan.
 - (3) 1,936 previously owned shares having a market value of \$25.33 per share were delivered in payment of the option price of \$22.05 per share for 2,225 shares acquired pursuant to the exercise of an option granted under the 1997 Plan.
