Vesting occurs in three equal installments beginning February 20, 2010.
  - (6) The restricted stock units were granted on February 20, 2010, with vesting to occur in three equal installments beginning February 20, 2011.  
The number of restricted stock units increases or decreases with actual earnings per share (for the fiscal year ended December 31, 2010, on a consolidated non-GAAP diluted basis) greater or less than target earnings per share, and the restricted stock units vest in three equal installments beginning February 20, 2011.
