- (1) The final tranche of a February 22, 2007 restricted share award vested on March 15, 2010. The Company withheld shares to satisfy the reporting person's tax obligation.

If the performance objective is achieved, this portion of the award will vest over the same four-year period. Upon vesting, each restricted stock unit converts into one Class A Common share of the Company.
