(1) The exercise reported was effected pursuant to a Rule 10b5-1 trading plan adopted by Mr. Trivedi on February 15, 2013.

This represents the difference between the number of SARs exercised (6,493) and the number of shares issued as a result of the exercise (2,253). The number of shares to be issued under a SAR exercise is determined by multiplying the number of SARs being exercised by the difference between the FMV on the date of exercise (\$89.695) and the exercise price (\$39.83). Additional shares are then withheld to satisfy the Company's tax withholding obligations.

(3) The sale reported was effected pursuant to a Rule 10b5-1 trading plan adopted by Mr. Trivedi on February 15, 2013.

This price represents the average sale price for multiple transactions on this line. The prices of the transactions reported on this line ranged from \$88.10 to \$88.57.
