 - (5) Until vested, the restricted stock unit shall be subject to forfeiture in the event of termination of employment or service with the issuer.
- The original restricted stock unit grant was for 12,000 restricted stock units on 11/17/2015. Subject to the reporting persons's continued
- (6) employment with the Issuer, the units vest and convert into shares of common stock (on a 1-for-1 basis) in four (4) equal annual installments beginning on 11/17/2016.
