The Registrant is filing this Registration Statement (this “**Registration Statement**”) to register an additional 906,345 ordinary shares, par value NIS 0.01 per share (“**Ordinary Shares**”), of Kornit Digital Ltd. (the “**Registrant**”) issuable pursuant to the Registrant’s 2015 Incentive Compensation Plan.

Pursuant to Instruction E of Form S-8, the contents of the Registrant’s registration statement on Form S-8 (File No. 333-203970) filed with the Securities and Exchange Commission (the “**Commission**”) on May 7, 2015 are incorporated herein by reference, and the information required by Part II is omitted, except as supplemented by the information set forth below.
