(1) The total amount of securities reported as indirectly owned by the reporting person includes 2.4700 shares acquired from December 1 through December 31, 2008, and a reduction of .6250 shares from January 1 through January 30, 2009, allocated to the reporting person's account in the Company's 401(k) Plan. To manage liquidity needs of the 401(k) Plan, the Plan Trustee from time-to-time maintains a lower overall share balance (versus cash) in the Plan, which in this latter instance resulted in a reduction in the number of shares allocated to the reporting person's account when compared to the reporting person's Form 4 filed on January 5, 2009. The information is based on a report dated January 30, 2009, provided by the Plan Trustee.

(2) Options vest according to the following schedule: 25% vest on the first anniversary of the award date, an additional 25% vest on the second anniversary of the award date, an additional 25% vest on the third anniversary of the award date, and the options become fully vested on the fourth anniversary of the award date.
