We expect that our results of operations will be significantly different from the corresponding period for the last year since we acquired new business operations earlier this year. We have not yet earned any revenues from operating our new business, though our operating losses of approximately \$210,000 for the year ended June 30, 2004 are lower than the corresponding period for the last year. Therefore, we expect that our net loss will be significantly lower than our losses last year of nearly \$450,000.
