GOL Announces Traffic Statistics for January 2009

São Paulo, February 6, 2009 - GOL Linhas Aéreas Inteligentes S.A. (NYSE: GOL and Bovespa: GOLL4), Brazil s low cost airline, today released preliminary passenger statistics for the month of January 2009. Domestic passenger traffic (RPK) for January 2009 increased 4.1% and capacity (ASK) increased 2.7% year-over-year (vs. January 2008). Domestic load factor for the month was 71% and international load factor was 57%. GOL s total system load factor for the month of January was 69%.
