**Minutes of the Board of Directors' Meeting held on May 6, 2011**

**1. Date, Time and Place:** On May 6, 2011, at 5 p.m., by conference call, as expressly authorized by Article 20, §2, of the bylaws of the Company.

**2. Call Notice and Attendance:** Present all members of the Company's Board of Directors, instatement and approval quorum having been verified.

**3. Presiding Board:** Chairman: Caio Racy Mattar. Secretary: Renata de Carvalho Fidale.

**3.1. Resolutions:** The members of the Board of Directors attending the meeting unanimously and with no restrictions decided to recognize the Company's capital increase, taking into consideration the limit of the authorized capital, in the amount of R\$1,540.22, due to the exercise, in the past 30 days, of stock options, which resulted in the issuance of 154,022 common shares, in accordance with the Subscription Bulletin, kept at the Company's headquarters. The abovementioned shares will take part in equal participating conditions, as the other existing shares, in all benefits, including in the possible distribution of dividends and in the payment of interest on net equity that may be declared by the Company as of the present date. As a result of the capital increase, the Company's corporate capital shall be R\$2,730,788,422.18, divided into 432,137,739 common shares, book-entry and without par value.

**4. CLOSING:** With no further matters to be discussed, these minutes were prepared, approved and signed by all members of the Board of Directors.
