As of the close of business on June 27, 2013, Integrated Core Strategies (US) LLC, a Delaware limited liability company ("Integrated Core Strategies"), beneficially owned 250,000 shares of the Issuer's Class A Common Stock and ICS Opportunities, Ltd., an exempted limited company organized under the laws of the Cayman Islands ("ICS Opportunities"), beneficially owned 50,625 shares of the Issuer's Class A Common Stock, which collectively represented 300,625 shares or 6.3% of the 4,790,694 shares of the Issuer's Class A Common Stock outstanding.

However, as of the close of business on July 3, 2013, Integrated Core Strategies beneficially owned 200,000 shares of the Issuer's Class A Common Stock and ICS Opportunities beneficially owned 27,022 shares of Issuer's Class A Common Stock, which collectively represented 227,022 shares or 4.7% of the 4,790,694 shares of Issuer's Class A Common Stock outstanding.

Millennium International Management LP, a Delaware limited partnership ("Millennium International Management"), is the investment manager to ICS Opportunities and may be deemed to have shared voting control and investment discretion over securities owned by ICS Opportunities.

Millennium International Management GP LLC, a Delaware limited liability company ("Millennium International Management GP"), is the general partner of Millennium International Management and may also be deemed to have shared voting control and investment discretion over securities owned by ICS Opportunities.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of the managing member of Integrated Core Strategies, and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. Millennium Management is also the general partner of the 100% shareholder of ICS Opportunities and may be deemed to have shared voting control and investment discretion over securities owned by ICS Opportunities.

Israel A. Englander, a United States citizen ("Mr. Englander"), is the managing member of Millennium Management and Millennium International Management GP and consequently may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies and ICS Opportunities.

The foregoing should not be construed in and of itself as an admission by Millennium International Management, Millennium International Management GP, Millennium Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies and ICS Opportunities.

(b) Percent of Class:

As of the close of business on July 3, 2013, Millennium Management and Mr. Englander may be deemed to have beneficially owned 227,022 shares of the Issuer's Class A Common Stock or 4.7% (see Item 4(a) above), which percentage was calculated based on 4,790,694 shares of Common Stock outstanding as of June 27, 2013, as per information contained in the Issuer's prospectus dated June 26, 2013 as filed with the Securities and Exchange Commission on June 28, 2013.
