Pursuant to Rule 416 under the Securities Act of 1933, as amended, this registration statement also covers additional shares that may become issuable under the above-named plan by reason of certain corporate transactions (1) or events, including any stock dividend, stock split, recapitalization or any other similar transaction effected without the receipt of consideration which results in an increase in the number of the registrant's outstanding shares of common stock.

The offering price is estimated solely for the purpose of determining the amount of the registration fee. Such estimate has been calculated in accordance with Rule 457(c) and Rule 457(h) and is based upon the average of the (2) high and low prices per share of the registrant's Common Stock as reported on the New York Stock Exchange on June 2, 2014.

## EXPLANATORY NOTE

This registration statement registers an additional 400,000 shares of common stock, par value \$0.01 per share (the "Common Stock"), of Brookdale Senior Living Inc. (the "Company") that may be issued and sold under the Brookdale Senior Living Inc. Omnibus Stock Incentive Plan (as amended and restated, the "Plan"). This registration of 400,000 shares of Common Stock will increase the number of registered shares available for issuance under the Plan to 14,100,000. As permitted by General Instruction E to Form S-8, the contents of the Company's Registration Statements on Form S-8 previously filed with the Securities and Exchange Commission (the "SEC") on November 21, 2005 (No. 333-129877), June 14, 2006 (No. 333-129877), June 26, 2008 (No. 333-151969), June 23, 2009 (No. 333-160164), January 31, 2013 (No. 333-186358) and December 11, 2013 (No. 333-192781) are incorporated herein by reference and made a part hereof.

The number of shares of Common Stock of the Company available for delivery under the Plan is subject to an automatic annual increase on the first day of each fiscal year of the Company commencing with the fiscal year beginning on or about January 1, 2006 by a number of shares equal to the lesser of (i) 400,000 shares of Common Stock or (ii) 2% of the number of outstanding shares of Common Stock. This registration statement registers the 400,000 additional shares of Common Stock resulting from the automatic annual increase that occurred on January 1, 2014.
