APPROVAL OBTAINED ON YUNNAN CHUXIONG NATURAL  
GAS CO-GENERATION NEW PROJECT

This announcement is issued pursuant to Rules 13.09(1) and (2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

Huaneng Power International, Inc. (the “Company”) announced that Huaneng Yunnan Chuxiong Natural Gas Co-generation New Project (the “Project”) (which is wholly owned by the Company) was recently approved by the Development and Reform Commission of the Yunnan Province.

The Project will build 2 x 300 MW class combined cycle gas turbine cogeneration units. The total investment amount of the Project is estimated to be approximately RMB2.656 billion, of which 20% will be project capital to be funded by the Company. The remaining investment is to be funded by bank loans.
