The registrant's net income for the three-month period ended August 31, 2014 is expected to be approximately \$352,673 compared to \$1,584,878 for the three-month period ended August 31, 2013.

The registrant's net income available to common shareholders for the three-month period ended August 31, 2014 is expected to be approximately \$214,498, or \$0.01 per share, compared \$1,448,652, or \$0.06 per share, for the three-month period ended August 31, 2013.

The decline in net income and net income available to common shareholders for the three-month period ended August 31, 2014 compared to the corresponding period in the prior year is primarily due to (1) an approximately \$445,000 decrease in revenues and (2) a provision for income taxes of \$152,700 for the three-month period ended August 31, 2014 compared to a tax benefit of \$237,000 for the corresponding period in the prior year.
