- Performance Share Units vest at December 31 following a three-year award period. At the end of the award period, the Compensation Committee determines the payment amount based on Company performance. The payment is made 100% in stock on a payment date determined by the Compensation Committee. The fair market value of the award is not determinable until the payment date.
- (1) Each performance unit is settled 100% in Vulcan common stock after deducting the amount of taxes due.
 - (2) Represents time-based restricted stock units ('RSUs') reported as shares of common stock. The reporting person has elected, upon the vesting thereof, to defer the receipt of these shares under the terms of the Company's Executive Deferred Compensation Plan.
 - (3) Convertible on a 1-for-1 basis.
 - (4) The units are to be settled in Vulcan common stock the year following the year of retirement of the reporting person.
