- (1) The purchase price for the securities that are the subject of the transaction described in this Form 4 was paid in New Israeli Shekels (NIS). The purchase price set forth in Table I is based on the representative exchange rate of the NIS to the U.S. dollar set by the Bank of Israel on the date of the transaction.
- (2) These shares are beneficially held directly by Bronicki Investments Ltd. Yehudit Bronicki is one of two directors of Bronicki Investments Ltd. and shares voting and dispositive power over the shares held by Bronicki Investments Ltd. Accordingly, Ms. Bronicki may be deemed to share beneficial ownership of the shares held by Bronicki Investments Ltd. However, Ms. Bronicki disclaims beneficial ownership of all such shares except to the extent of her pecuniary interest therein.

1. Bronicki Investments Ltd. and Yehudit Bronicki acted in concert with FIMI in connection with certain Voting and Undertakings.
2. On November 2, 2015, Yehudit Bronicki informed the board of directors of Ormat Technologies, Inc. (the "Company") that she was a director of the Company.
