The Restricted Stock Unit award agreements contain tax withholding provisions which allow us to satisfy tax withholding obligations by netting shares. Award will vest on February 21, 2017 and will be settled in shares.

Transaction represents the satisfaction of EPS/TSR/ROTCE performance conditions. Award will vest on February 21, 2017 and will be settled in shares of common stock.
