**TASEKO CHANGES FISCAL YEAR END AND ANNOUNCES  
FOURTH QUARTER EARNINGS RELEASE DATE**

**October 9, 2008, Vancouver, BC** - Taseko Mines Limited (TSX: TKO; AMEX: TGB) ("Taseko" or the "Company") today announced that it will change its fiscal year end to December 31<sup>st</sup>, from its current fiscal year end of September 30<sup>th</sup>.
