Pursuant to Rule 13d-2 promulgated under the Act, this Schedule 13G/A (this "Amendment No. 2") amends the Schedule 13G filed on September 18, 2009 (the "Original Schedule 13G") as amended by the Schedule 13G/A filed on February 16, 2010 ("Amendment No. 1") (the Original Schedule 13G, Amendment No. 1 and this Amendment No. 2 are collectively referred to herein as the "Schedule 13G"). This Amendment No. 2 relates to the shares of common stock, par value \$0.001 per share, of Incyte Corporation, a Delaware corporation (the "Issuer"). Unless the context otherwise requires, references herein to the "Common Stock" are to such common stock of the Issuer.
