In connection with the Agreement and Plan of Merger, dated as of November 5, 2014, as amended, by and among SKBHC Holdings LLC, Starbuck Bancshares, Inc., Elements Merger Sub, LLC and Banner Corporation, we granted registration rights to certain shareholders that had received restricted securities as part of the merger consideration.
