This inadvertent reporting error included (i) 14,767 shares withheld at \$16.19 per share in connection with 43,035 RSUs that vested on May 15, 2014; (ii) 5,133 shares withheld at \$16.49 per share in connection with 15,659 RSUs that vested on February 15, 2015; and (iii) 23,148 shares withheld at \$35.14 per share in connection with 53,396 RSUs that vested on May 15, 2015. The reported ownership also includes 1,088 shares acquired under the Issuer's 2012 Employee Stock Purchase Plan.
