Glenview Capital Management serves as investment manager to each of Glenview Capital Partners, Glenview Capital Master Fund, Glenview Institutional Partners, Glenview Offshore Opportunity Master Fund, Glenview Capital Opportunity Fund, GCM Master Fund and the Managed Account. Mr. Robbins is the Chief Executive Officer of Glenview Capital Management.

This amount consists of: (A) 121,525 Shares held for the account of Glenview Capital Partners; (B) 1,686,018 Shares held for the account of Glenview Capital Master Fund; (C) 937,764 Shares held for the account of Glenview Institutional Partners; (D) 1,187,009 Shares held for the account of Glenview Offshore Opportunity Master Fund; (E) 933,479 Shares held for the account of Glenview Capital Opportunity Fund; (F) 211,678 Shares held for the account of GCM Master Fund; and (G) 273,901 Shares held for the Managed Account.
