(28) On August 16, 2007, the Special Situations Fund entered into an equity swap transaction with DB, under which DB agreed to pay the Special Situations Fund an amount equal to any increase, and the Special Situations Fund agreed to pay DB an amount equal to any decrease, in the official market price of 83,333 notional shares above or below an initial reference price of US\$48.2052 per share upon close-out of any transaction.

(29) On July 30, 2008, the Special Situations Fund entered into an equity swap transaction with TradIndex, under which TradIndex agreed to pay the Special Situations Fund an amount equal to any increase, and the Special Situations Fund agreed to pay TradIndex an amount equal to any decrease, in the official market price of 53,000 notional shares above or below an initial reference price of US\$54.10 per share upon close-out of any transaction.
