June 15, 2010 - Athens, Greece - Seanergy Maritime Holdings Corp. (the "Company") (NASDAQ: SHIP; SHIP.W) announced today that on Monday, June 14, 2010, the Company's Chief Executive Officer, Mr. Dale Ploughman, purchased 50,000 shares of Seanergy's common stock at a purchase price of \$1.2399 per share. The transaction was completed on the open market.

In May 2010, the Company acquired a controlling interest in Maritime Capital Shipping Limited, which owns nine Handysize dry bulk carriers.

The Company's current controlled fleet includes 20 drybulk carriers (four Capesize, three Panamax, two Supramax and one Handymax and 10 Handysize vessels) with a total carrying capacity of approximately 1,292,544 dwt and an average fleet age of 12.7 years.
