Item 3.02. Unregistered Sales of Equity Securities.

On November 26, 2007, Alabama Power Company issued to The Southern Company, in a private placement, 2,225,000 shares of Alabama Power Company's common stock, \$40.00 par value per share, for an aggregate purchase price of \$89,000,000. There were no underwriting discounts or commissions. The issuance to The Southern Company was exempt from registration under the Securities Act of 1933, as amended (the Act), pursuant to Section 4(2) of the Act because it was a transaction by an issuer that did not involve a public offering.
