Item 1. Security and Issuer

This statement relates to the Common Stock, par value \$0.10 (the "Shares"), issued by Navistar International Corporation (the "Issuer"). The address of the principal executive offices of the Issuer is 4201 Winfield Road, P.O. Box 1488, Warrenville, Illinois 60555.

Item 2. Identity and Background

Icahn Enterprises Holdings is the sole member of IPH, which is the general partner of Icahn Capital. Beckton is the sole stockholder of Icahn Enterprises GP, which is the general partner of Icahn Enterprises Holdings. Carl C. Icahn is the sole stockholder of each of Barberry and Beckton. As such, Mr. Icahn is in a position indirectly to determine the investment and voting decisions made by each of the Reporting Persons.
