- (1) The Human Resources Committee of the issuer's board of directors granted Mr. Picasso this award of Class A common stock on April 26, 2006, subject to final approval by the issuer's chairman of the board, which approval was given on May 10, 2006.
- (2) Mr. Picasso was granted 180,000 shares of performance-based restricted Class A common stock at "target" performance. The potential number of shares that will actually vest, which will be based on the issuer's revenue and adjusted EBITDA during fiscal years 2006, 2007 and 2008, will range from 0% to 150% of target (i.e., 0-270,000 shares).
