Payment at Maturity

For each \$1,000 stated principal amount you hold at maturity:

- If the final basket value is **greater than** the initial basket value:

\$1,000 *plus* the lesser of:

(i)  $\$1,000 \times \frac{\text{final basket value} - \text{initial basket value}}{\text{initial basket value}} \times \text{participation rate}$ ; and

(ii) the maximum return at maturity

If the final basket value is **less than or equal to** the initial basket value, but **greater than or equal to** the buffer value, \$1,000

- If the final basket value is **less than** the buffer value, \$1,000 *minus*:

$$\$1,000 \times \frac{\text{buffer value} - \text{final basket value}}{\text{initial basket value}}$$
