Sappi Limited, the global pulp and paper group, announced today that Mr Robert (Bob) J DeKoch will join the board as an independent non-executive director as from 01 March 2013.

Mr Bob DeKoch is currently the President and Chief Operating Officer (COO) of The Boldt Company in Appleton, Wisconsin, USA. The Boldt Company with 14 offices across the USA is a US\$700 million privately held construction services business with customers in power/energy; pulp and paper; food; automotive; plastics; healthcare; and education.

Prior to joining The Boldt Company, Mr DeKoch served as a production manager and mill manager as well as VP of manufacturing for Appleton Papers (USA). He also served inter alia as technical director of Consolidated Papers (USA). Mr DeKoch holds a BA Chemistry and an MBA in Finance and General Management.
